Report Purpose	For Council to determine an application to amend a development approval (which has already been carried out) for the enclosure of lean-to farm building to be used for 'Agriculture – Extensive' on Lot 1496 (No. 31104) Brand Highway, Bonniefield.
Discussion	Manager Development spoke to the item and provided clarity on the history of the previous approvals and the alterations to the shed that were made without approval by the applicant. Additionally Council were updated on discussions with MRWA regarding Brand Highway access. Main Roads WA official position remains that access to Brand Highway be restricted especially when there is a safer alternative access route. Council were asked to consider extending the deadline to the end of April 2025 for the applicant to complete the required tasks taking into consideration weather conditions for road construction, and any additional paperwork requirements which may be needed.
